## Oral Performance Examinations

Candidates who have attended the two-day orientation workshop, passed the online written examination, and have achieved registration status with the Court Interpreter Certification and Regulation Program may take the 1-hour oral performance examination testing their skill in sight translation, consecutive and simultaneous interpretation.

Full oral examinations are currently available in Arabic, Cantonese, French, Haitian Creole, Hmong, Ilokano, Khmer, Korean, Laotian, Mandarin, Polish, Portuguese, Russian, Somali, Spanish, Tagalog, and Vietnamese.
