## ADMINISTRATIVE ORDER

The Trial Court Budget Commission was created to oversee the preparation and implementation of the trial court component of the judicial branch budget. The Commission is directly responsible for recommending budgeting and finding policies and procedures for the trial court budget in order to support a trial court system that will effectively carry out the administration of justice. See Fla. R. Jud. Admin. 2.053.


Staff support and expenses for the Commission will be provided by the Office of the State Courts Administrator.
