Overview

The Judicial Inquiry System (JIS) is a single-entry application solution by the Office of the State Courts Administrator that offers the judiciary and other authorized agencies access to multiple criminal justice data sources.

- Web-based system that does not require software installation
- 24/7 availability and support
- Secure access application used to query information from multiple data sources (state, local, federal)
 - APPRISS
 - Florida Court Clerks and Comptrollers Comprehensive Case Information System (CCIS)
 - Florida Department of Corrections (DOC)
 - Florida Department of Juvenile Justice (DJJ)
 - Florida Department of Highway Safety and Motor Vehicle (DHSMV)
 - Florida Crime Information Center (FCIC)
 - National Crime Information Center (NCIC)
- Single point of entry and logon/password to query multiple data sources
- User role-based profiles (judges, case managers, state attorneys, public defenders, sheriffs, etc.)
- Efficient investigative tool utilizing match scoring, visual alert flags, and consolidated search results from multiple data sources

JIS consists of three components:

- ✓ *Judicial Inquiry System (JIS) Search*
- ✓ *Jessica Lunsford Act (JLA) First Appearance Calendar*
- ✓ *Active Warrant Alert Calendaring System (AWACS)*

Judicial Inquiry System

Judicial Inquiry System (JIS) Search

JIS Search allows a user to perform a single criminal record search simultaneously from multiple data sources. Responses are matched and merged to provide a cohesive and comprehensive view. JIS is role-based, allowing agencies to customize access to data sources for each user.

The Judicial Inquiry System reduces search time while providing access to a variety of data sources, including:

APPRISS	Jail booking information and images throughout Florida and other states
Comprehensive Case Information System	Florida Clerk of Court case information for all case types
Department of Highway Safety and Motor Vehicles	Florida driver, vehicle, and vessel information including photos and signatures (DAVID = Driver and Vehicle Information Database)
Department of Juvenile Justice	Florida DJJ juvenile arrest, probation, incarceration, and disposition information and photos
Department of Corrections	Florida DOC supervised, incarcerated, absconded, and released inmate information and photos
Florida/National Crime Information Center (FCIC/NCIC) Hot Files	FCIC and NCIC status files of persons and photos Ex. Warrants, High Risk Sex Offenders, Violent Felony Offenders of Special Concern, Active injunctions, Gang Members, Deported Aliens, Career Offenders, Immigration Violators, and injunctions
FCIC/NCIC Protection Order	Active, Expired, and Cleared injunction information
FCIC Rap sheet	Florida arrest and disposition information
Florida Summary	Summarized format of Florida rap sheet
Florida Concealed Weapons	Concealed Weapons Permit information
NCIC Rap Sheet	Out-of-state arrest and disposition information
NCIC Out-of-State Driver License	Driver license history information with simultaneous search up to 5 states

Jessica Lunsford Act (JLA) First Appearance Calendar

The JLA First Appearance Calendaring System creates an automated docket of merged data source responses for arrestees in each county in the State of Florida. This feature provides an efficient and streamlined approach to reviewing criminal histories for First Appearance preparation. The JLA First Appearance Calendar is available to judges, state attorneys, public defenders, pretrial services, and sheriffs' deputies to access automated merged records of current arrestees.

The JLA First Appearance Calendar functionality includes:

- Secure access to criminal history search results for subjects booked for each county throughout Florida
- Real-time booking information via Appriss and FDLE Live Scan systems
- Automated queries of various systems to compile computerized criminal history records
- Alerts based on statute and criminal history record responses (*HRSO, VFOSC, sexual predators/offenders, violations of probation, outstanding warrants, injunctions*)
- Real-time alert notification of High Risk Sex Offender and Violent Felony Offender of Special Concern subjects to First Appearance staff and other authorized recipients via email
- Access to date specific First Appearance calendars
- Ability to add, delete, and move subjects on the calendar
- Ability to modify First Appearance cutoff times
- Ability to conduct batch printing of FCIC and NCIC information for all calendar subjects
- Administrative user functions to customize the calendar view

Active Warrant Alert Calendaring System (AWACS)

AWACS performs automated searches on subjects scheduled to appear at court events subsequent to First Appearance. It provides an automated link between JIS, the Clerks of Court calendar information (CCIS), the FCIC/NCIC warrant information systems, the APPRISS booking system, and law enforcement agencies charged with execution of warrants.

AWACS can:

- Perform automated queries of multiple data sources including warrant checks and custody status
- Display alerts based on statute and criminal history record responses (*HRSO, VFOSC, sexual predators/offenders, violations of probation, outstanding warrants, injunction*)
- Provide real-time alert notification of High Risk Sex Offender and VFOSC to authorized recipients
- Conduct batch printing of data source responses
- Allow administrators to customize the calendar
