IN RE: FLORIDA COURTS TECHNOLOGY COMMISSION

ADMINISTRATIVE ORDER

The purpose of the Florida Courts Technology Commission is to oversee, manage, and direct the development and use of technology within the judicial branch. The Commission is directly responsible for recommending technology policies and procedures for the judicial branch, in order to support a court system that will effectively carry out the administration of justice. One of the primary objectives of the Commission is ensuring the creation of a compatible technology infrastructure that provides timely, consistent, and useful information by enhancing technology solutions, improving case management, and supporting efficiencies that meet the needs of the judicial branch and court users.

In performing its responsibilities, which are prescribed in Rule of Judicial Administration 2.236, the Commission shall be guided by the goals of the Long-Range Strategic Plan for the Florida Judicial Branch 2016-2021. These include but are not limited to Goal 4.3 (Create a compatible technology infrastructure to improve case management and meet the needs of the judicial branch and court

users), Goal 4.4 (Improve data exchanges and integration processes with the clerks of court and other justice system partners), Goal 4.5 (Modernize court processes through automation and expand self-service options for court users), and Goal 4.2 (Safeguard the security, integrity, and confidentiality of court data and technology systems).

To avoid majority turnover in any year, the Commission established a system of staggered, three-year terms. Some members' terms expired on June 30, 2018. Accordingly, the following individuals are appointed to serve as members of the Commission for a term to expire on June 30, 2021:


